ART DISPLAY IN AIRPORT

The Roanoke Regional Airport Commission is seeking proposals for six temporary public works of art representing the artist's artistic vision representing aviation to be on display at the Roanoke-Blacksburg Regional Airport in Roanoke, Virginia. The display will consist of art to be displayed on the second floor corridor on the west end of the terminal building from January 16, 2018 – April 16, 2018. The Commission is not accepting sculpture at this time.

Selection Committee

The Selection Committee is comprised of members from the Roanoke Regional Airport Commission team, and the Radford University College of Visual and Performing Arts.

Artists living and/or working within the region (the airport's 19-county passenger service area) who wish to be considered for exhibitions in the Roanoke-Blacksburg Regional Airport may submit electronic images of their work with supporting materials. **Please adhere to the following guidelines:**

- 1. Current résumé or CV (an additional descriptive biography is optional)
- 2. Artist statement
- 3. Letter of introduction
- 4. Ten or more electronic images of work completed within the last 5 years; images should be in jpg format and should not exceed 1mgb each.

- 5. Checklist that includes the file name, title, medium, dimensions, and year completed.
- 6. Visual representation of what the proposed artwork will look like.
- 7. Written site-specific proposal description (maximum 3 pages)
- 8. Must include: Dimensions of each piece, weight and installation method.
- 9. Project may NOT include: elements requiring electricity or maintenance after installation.
- 10. Hard copies of submissions will not be accepted. Selection of artists will be done by juried selection. No artist interviews or presentations will be allowed beyond the materials submitted.
- 11. Each artist may submit no more than two applications.

Important Considerations for Artists:

The Roanoke-Blacksburg Regional Airport is a busy public venue, and its exhibition space presents artwork that adheres to established public art content standards. We do not exhibit work that includes nudity, overt political references, offensive language, violence and natural or human-made disaster imagery. Artist must sign an agreement with the Roanoke Regional Airport Commission. Copies of this agreement are available upon request (amandad@flyroa.com).

Gallery spaces are largely unmonitored, and exhibitions remain on view for up to 90 days. While

we take reasonable precautions to protect artwork, there may be pieces that are unsuitable for our

environment due to inherent fragility, or technical requirements.

De-installation of Exhibit: April 16, 2018

Selection Criteria

All required application materials must be included in submission and received by submission deadline.

Work selected on artistic merit as evidenced by submitted visual materials.

Roanoke Regional Airport Commission staff and their immediate families, are not eligible to apply for this project.
