#### **JOB SUMMARY:**

Under general supervision of the Operations Manager and/or Operations Supervisor, monitors airfield, airport facilities, and personnel to ensure compliance with FAA, TSA, and Commission regulations and leases.

#### **ESSENTIAL JOB FUNCTIONS:**

- 1. Monitors and performs inspections of both airside and landside airport property and facilities to ensure Commission's and tenants' compliance with FARs 77, 139, TSR's 1520, 1540, 1542, and the safety of all users of the airport;
- 2. Reports discrepancies and unsafe conditions in a timely and accurate manner via work orders and use of the NOTAM system;
- 3. Assists in the development and updates of FAA required and other manuals and plans;
- 4. Assists in research for and preparation of bid specifications as requested;
- 5. Provides escorts inside the AOA and SIDA areas;
- 6. Coordinates with construction contractors:
- 7. Conducts runway inspections;
- 8. Performs snow removal and related duties, including friction testing and field condition reporting;
- 9. Serves as representative of Department in absence of senior operations personnel;
- 10. Performs necessary duties contributing to a clean, safe environment, ensuring compliance with Commission and applicable government regulations;
- 11. Monitors/participates in snow removal operations during assigned shift;
- 12. Performs necessary administrative duties contributing to the efficiency of Commission operations;
- 13. Conducts training and presentations on a variety of topics for groups of varying size and backgrounds;
- 14. Consistently exhibits satisfactory levels of performance and behavior;
- 15. Ensures work area and tasks are completed in an organized and timely manner;
- 16. Complies with established safety and security policies/procedures and performs all duties in a safe manner according to Commission, Federal and State regulations;
- 17. Wears and uses all required safety equipment and/or protective clothing at all times;
- 18. May be exposed to all types of weather conditions;
- 19. Performs other duties as may be assigned.

#### **KNOWLEDGE, SKILLS AND ABILITIES:**

- In lieu of a four year or two year related degree, a combination of education and experience performing essential job functions at a 139 certified airport may be considered on a year-for-year basis;
- AAAE ACE (Ops) or Certified Member (C.M.) designation desirable.

- Works rotating shifts including nights/evenings, weekends and holidays; subject to recall and round-the-clock operations when required;
- Valid Virginia driver's license will be required, CDL preferred and required within one (1) year of hire and have and maintain driving record acceptable to the Roanoke Regional Airport Commission and its insurance carrier(s);
- Must meet and maintain TSA security requirements for unescorted access to the Airport's Secure Area and all other Air Operations Areas.
